

GDPR Cookie Policy

1. Application

This policy applies to all employees, contractors, and vendors while doing business with Söderberg & Partners Heartpace AB (hereafter referred to as Heartpace) and others who have access to European Union (EU) and the European Economic Area (EEA) data subject information ("personal data") in connection with S&P Heartpace AB's operating activities.

2. Policy

Heartpace is committed to safeguard the integrity of our customers and users. In this policy we share openly and transparent how we collect and use cookie data.. This policy provides information about how and when S&P Heartpace AB uses cookies for these purposes. Capitalized terms used in this policy but not defined have the meaning set forth in our Privacy Policy, which also includes additional details about the collection and use of information at Heartpace.

What is a cookie?

Cookies are small text files sent by us to your computer or mobile device, which enable S&P Heartpace AB features and functionality. They are unique to your account or your browser. Session-based cookies last only while your browser is open and are automatically deleted when you close your browser. Persistent cookies last until you or your browser delete them or until they expire(Expiration date displayed in cookie manager).

Does S&P Heartpace AB use cookies?

Yes, Heartpace uses cookies and similar technologies like single-pixel gifs and web beacons. Heartpace uses both session-based and persistent cookies. S&P Heartpace AB sets and accesses cookies on the domains operated by Heartpace. In addition, Heartpace uses third party cookies, like Google Analytics V4/Hotjar/Intercom as specified in the table below..

How is Heartpace using cookies?

Some cookies are associated with your account and personal information to remember that you are logged in and which workspaces you are logged into. Other cookies are not tied to your account but are unique and allow us to carry out analytics and customization, among other similar things. Cookies can be used to recognize you when you visit Hesrpace.com or use our Services, remember your preferences, and give you a personalized experience that is consistent with your settings. Cookies also make your interactions faster and more secure. Visit our cookie tables to learn more.

Categories of use

- **Authentication:** If you're signed into the Services, cookies help Heartpace show you the right information and personalize your experience.
- **Preferences, features, and services:** Cookies denote which language you prefer and what your communications preferences are. They can help fill out forms on our Sites more easily. They also provide you with features, insights, and customized content.
- **Marketing:** Heartpace may use cookies to help deliver marketing campaigns and track their performance (e.g., a user visited heartpace.com, booked a demo or sent a contact request). Similarly, Heartpace's partners may use cookies to provide us with information about your

interactions with their services, but use of those third-party cookies would be subject to the service provider's policies.

- **Performance, Analytics, and Research:** Cookies help Heartpace learn how well the Sites and Services perform. Heartpace also uses cookies to understand, improve, and research products, features, and services, including to create logs and record when you access our Sites and Services from different devices, such as your work computer or your mobile device.

How are cookies used for advertising purposes?

Please note that disabling a cookie or category of cookies does not delete the cookie from your browser unless manually completed through your browser function.

2. Cookies Set in the Past

Collection of your data from our analytics cookies can be deleted. If cookies are deleted, the information collected prior to the preference change may still be used. However, we will stop using the disabled cookie to collect any further information from your user experience. For our marketing cookie, when a user opts out of tracking, a new cookie is placed to prevent users from being tracked.
